WELCOME



We are grateful to the entire Texas McCombs community of faculty, staff, employers, and alumni who have come together to support our MSF Class of 2024. This year, 93.4% of our students secured job offers within six months of graduation, with a average starting salary of \$81,227—a notable increase of 14% since 2020.

Our career management team strategically tailored our MS career curriculum and programming to align with the shifting dynamics of the recruiting landscape and the evolving interests of our students. This proactive approach has equipped our graduates with the necessary skills to both successfully launch and develop their careers over time.

Many of our MSF graduates consistently secure positions in the Financial Services industry. In 2024, we saw growth in this sector with 39% of graduates accepting roles. Other strong industries for our MSF graduates include Consulting (21%), Energy (9%), and Manufacturing (9%). MSF graduates are securing functional area roles in Corporate Finance (32%), Investment (23%), Consulting (23%) and Banking (18%) across these industries, demonstrating the comprehensive skills, interests, and adaptability of our students.

Geographically, the majority of our Texas MSF graduates, 86%, are opting to stay in the Southwest region, working in major Texas cities. Additionally, 6% of graduates relocated to the Northeast and Mid-Atlantic regions, with others also securing opportunities in the Midwest and West.

We have continued to invest in growing the MSF employer ecosystem, and that investment is paying dividends with new opportunities. Notably, 62% of MSF 2024 graduates secured offers from school-facilitated resources, reflecting our students' achievements and the strength of our ecosystem.

The MSF Class of 2024 exemplifies the program's ability to prepare graduates for a dynamic job market. As our alumni network grows, we remain committed to strengthening career pathways and expanding opportunities for future MSF students.

Congratulations to the MSF Class of 2024, and thank you to our McCombs community for your continued support in shaping the success of our students.




