## 1. Program Overview

Texas McCombs Investment Advisers (TMIA), formerly known as the MBA Investment Fund, is a private investment company founded in 1994. The Fund currently manages about **\$25 million** across two portfolios:

- **Longhorn Fund** large-cap U.S. equity portfolio benchmarked to the S&P 500.
- **Endowment Fund** diversified multi-asset portfolio managed primarily through ETFs.

Each year, TMIA selects ~20 MBA students to serve as **portfolio managers**. Students gain hands-on experience in all aspects of investment management, including:

- Security and sector analysis
- Portfolio construction and rebalancing
- Performance attribution and reporting
- Working with faculty and industry professionals

### 2. Eligibility

To apply, you must:

- Be a **first-year full-time MBA student** at McCombs.
- Submit a **PDF application packet** (resume + required sections) by 09/23/2025.
- Participate in two interview rounds (First Round: 09/29/2025, Second Round: 10/13/2025).
- If selected, commit to:
  - o **Houston Trek** (12/16/2025 to 12/17/2025)
  - o **Finance Bootcamp** (01/07/2026 to 01/09/2026)
  - Fund-related activities throughout Spring 2026 Fall 2026
  - o Required coursework: *Investment Theory (Spring 2026)* and *Valuation (Fall or Spring)*
  - Completion of Wall Street Prep: Financial Modeling + DCF modules

### 3. Selection Process

- Applications reviewed by second-year fund managers + faculty.
- Shortlisted candidates invited to interview.
- Final decisions announced shortly after second-round interviews.
- By applying, you consent to sharing your resume with potential employers.

## 4. Application Components

#### 4.1 Section I - Resume

Attach a **one-page resume** including: name, email, phone, education (with GPA + GMAT/GRE), experience, certifications, languages, and personal interests.

#### 4.2 Section II – Personal Statement

In  $\leq$  400 words (max 1 page), answer:

- Why do you want to join TMIA?
- What skills, experiences, or character traits will help you contribute to the Fund's success?

### 4.3 Section III - Stock Pitch

In  $\leq$  600 words (max two pages), answer:

- Which U.S. publicly traded stock should TMIA consider?
- Why is this stock a good investment?
- How much (relative to the benchmark) should we allocate?

(A detailed valuation model is not required; focus on clear reasoning and qualitative analysis.)
